BYLAW NUMBER 1067

Being a bylaw of the Town of Golden to provide for the setting of fees and charges for administrative services of the Town.

**WHEREAS** the Local Government Act, Section 323 RSBC 1996 provides for Council to set fees and charges to cover reasonable costs of providing administrative services;

**NOW THEREFORE**, the Council of the Town of Golden, in open meeting assembled, **HEREBY ENACTS AS FOLLOWS:**


1. Fees and charges for administrative services of the Town shall be as set out in Schedule "A" attached.
2. The Town of Golden "Fee Setting Bylaw Number 871, 1992" is hereby repealed.
3. This Bylaw may be cited as "Town of Golden Fees and Charges Bylaw Number 1067, 2001".
